

### NCEES Structural Exam Task Force

- 2006–07 charge: Evaluate existing Structural exams and make recommendations for modifications to the SE exams so that a common exam can be used by all NCEES member boards that license structural engineers by 16 hours of examination.
- Voted at the 2008 annual meeting to move forward with the 16-hour exam

#### New Exam Format

- Two 8-hour components
- Breadth and depth
- Integrated design, analysis, and detailing questions
- No single component of the exam is a sufficient stand-alone exam for any purpose.
- See NCEES Web site for exact specifications.



#### Exam Format (continued)

- Vertical Forces (Gravity/Other) and Incidental Lateral Component—offered on Friday only
  - Analysis and design for gravity forces and incidental lateral forces from soil, ice, etc.
  - Morning: 4 hours, 40 multiple-choice problems
  - Afternoon: 4 hours, constructed-response problems
    - Four 1-hour building problems OR
    - One 2-hour and two 1-hour bridge problems



#### Exam Format (continued)

- Lateral Forces (Wind/Earthquake) Component offered on Saturday only
  - Analysis and design for lateral forces—high wind and high seismic
  - Morning: 4 hours, 40 multiple-choice problems
  - Afternoon: 4 hours, essay problems
    - Four 1-hour building problems
      - Two problems in SDC D and one wind problem with wind speed at 110 mph or higher

OR

• One 2-hour and two 1-hour bridge problems



#### Passing the Exam

- Each component may be taken in separate administrations or on consecutive days in the same administration.
- Candidate must successfully complete both components to pass the exam.
- *Model Law* and *Model Rules* were revised to add a 5-year limit to pass the second component once a candidate successfully completes his or her first component. This can be adopted on a state-by-state basis.
- At the 2011 annual meeting, EPP is proposing policy language to match the *Model Law* and *Model Rules*.



#### Scoring the Exam

• How do we ensure that a candidate doesn't obtain acceptable results in a component by performing well in the morning (multiple choice) but poorly in the afternoon (constructed response)?

#### Partial Compensatory Scoring

- This scoring method allows a candidate to make up some points in the morning portion but requires a minimum number of points in the afternoon portion.
- The purpose is to ensure that a candidate doesn't "ace" the morning (multiple choice) and "flub" the afternoon (constructed response) and still obtain acceptable results.
- This is the method NCEES is using.



#### **Transition**

- Candidates who have passed SE II will have one more exam administration to pass the WA SE III exam if they want to be licensed in Oregon or Washington without taking the new exam.
- Candidates who have passed SE II will have one more exam administration to pass the CA SE III exam if they want to be licensed in California without taking the new exam.
- All other candidates who have not met the requirements will need to pass the new 16-hour exam to be licensed in those states requiring 16 hours of examination.



#### Frequently Asked Questions

- If I have passed SE I, can I exempt the first day of the new 16-hour exam?
  - -No
- Can I "pass" one day of the new exam and be licensed as a P.E. since I would have passed 8 hours of examination?
  - No, the 16-hour exam is not designed to test minimal competence with just one component.



- Assume I pass both SE I and SE II by the end of 2010 and sometime in the future want to be licensed in a state that currently requires both SE I and SE II but will soon require the new 16-hour exam. Will I have to take the new 16-hour exam at that time?
  - Most boards base reciprocity requirements on the licensing requirements at the time the applicant took his or her exam(s).

- If I am licensed in a state currently requiring SE I for licensure and the state changes to require the new 16-hour exam, will I need to pass the new exam to maintain my license?
  - That will depend on the state, but in most cases, probably not.



- Will passing the new 16-hour exam be the equivalent of passing SE I and SE II?
  - No, the new exam has high seismic and high wind content that is not in the current SE I and SE II exams. Boards may use this exam differently.

- If I achieve an acceptable result on the Vertical or Lateral component of the exam and fail the other component, will I have to retake both?
  - No, but there is no credential awarded for achieving acceptable results on one component only.
  - Some boards may give a limited window of time to achieve an acceptable result on the second half of the exam.

#### **Questions for Member Boards**

- If candidates failed either STRI or STRII, are they considered "retakers" or "first-time takers" with regard to the new exam?
- If a member board has a "retake" policy, will it apply to the components separately or the exam as a whole?
  - Example: If a candidate attempts the Vertical component three times and the Lateral component once, has he or she attempted the exam three times or one time?
- If someone who has passed the STRI and STRII applies for an S.E. license by comity, will you grant approval (assuming you used to license S.E.s by passing the STRI and STRII)?



#### Questions for Member Boards

- Will a member board accept the PE Civil—Structural exam for a P.E. license? S.E. license?
- Will a member board accept the 16-hour SE exam for a P.E. license?
- If a candidate passes the new exam in a state that has an S.E. license, will he or she receive both a P.E. and an S.E. license?
