## Examination Administration Dates

Most dates were recorded in the reports of the Uniform Examinations Committee (through 1989) or Committee on Examination Policy and Procedures.

1965:	December 4 (FE only)	
1966:	April 23 (FE only)	December 3 (FE and first PE)
1967:	April 21–22	December 1–2
1968:	April 26–27	December 6–7
1969:	April 25–26	December 5–6

In 1970, the Uniform Exams Committee recommended that states offer the PE on either Thursday or Friday and the FE on either Friday or Saturday.

1970:	April 16–18	December 3–5

In 1972, the Uniform Exams Committee recommended that boards be allowed to give PE exams on Thursday or Friday and FE exams on Saturday or Sunday (effective 1975).
