#### MISSOURI REPORT TO NCEES CENTRAL ZONE 2022

- 1. **APPOINTMENTS TO BOARD:** Since the last report, David Smith, PE and Dan Govero, PLS are no longer on the Board. Shane Terhune, PLS is the newest member to be appointed and confirmed.
- 2. Board staff is experiencing a turnover with several new people being added and others assuming new roles. However, the Board and staff are continuing to operate at the same high level of consistency and professionalism that our licensees have come to expect and appreciate.
- 3. Our continuing challenges are occurring in the legislature where battles within the majority party have pretty much brought the Senate to a standstill, and very little being approved and sent to the Governor.
- 4. We are continuing to watch proposed edits to the Land Surveying statutes and watch for any last minute amendments affecting the other three professions.
- 5. We have adapted to the changes in Comity licensure passed last session at the last minute by the legislature. It created paths to licensure which were not allowed previously and, in some cases, make it easier for an out of state PE to obtain licensure in Missouri than an in state resident.
- 6. Our participation in the Design Alliance (all professional societies representing licensees and the Board) continues to work for all involved to get information distributed and a forum for discussion on issues that affect the licensees. A united coalition of member societies through their respective lobbyist approach the Legislature with a unified position on bills of interest.

#### **Indiana PE Report**

An Electronic Meeting Policy was reviewed by the board and the present polocy will be revised our policy to include updates.

Jason Durr was elected Chair, Greg Morical was elected Vice Chair, and Tim Jensen was elected Board Liaison for 2022.

El and PE data from the past three years is as follows: Number of licenses issued:

2019: EI - 196 PE - 898

2020: EI-164 PE-766

2021: EI – 234 PE – 916

To date, there have been 128 EI licenses and 456 PE licenses issued in 2022.

The Board has had lengthy discussions regarding decoupling. The board understands that there are currently approximately 24 states that have some version of decoupling, including neighboring states of Illinois, Kentucky, and Michigan. These discussions continue.

The Administrative staff asked for some guidance from the Board to reduce reviews of applications to take the PE Exam. The Board discussed the options and worked with legal counsel to determine that 864 IAC 1.1-4.1-2 will allow an applicant to sign an affidavit stating that they have an ABET accredited degree, passed the FE Exam, and will have the 4 years of experience prior to taking the PE Exam. The signed affidavit will be presented to the NCEES in order to schedule the PE Exam. If the applicant does not meet the specific requirements in the affidavit, they will need to apply to the Board for approval prior to scheduling their PE Exam with NCEES. This approach is consistent with several other states. The Board is having a draft version of the affidavit prepared for review.

The Board held a hearing to readopt it's rules (864 IAC 1.1-1-3 through 1.1-15) regarding the State Board of Registration for Professional Engineers. This is required every seven years per IC 4-22-2.5-2. The Board voted unanimously to readopt the rules.

RE: North Dakota Board of Registration for Professional Engineers and Land Surveyors (NDPELS) Yearly Update

Fellow NCEES Members,

The North Dakota Board of Registration for Professional Engineers and Land Surveyors (NDPELS) has had a busy year managing change and developing futuristic plans.

In effort to increase commercial registration within North Dakota, the staff initiated an outreach effort to past commercial registrants, which some dated back to 2017. Of the 399 mailouts/emails, we were able to regain over 110 lapsed licensures.

The Board conducted a strategic planning session in July of 2021, which resulted in the establishment of ten objectives. The plan is for calendar years 2021 through 2025. The major efforts of the plan include the review and rewrite of North Dakota specific exams, which was completed in June of 2022 and further automating our licensure processes.

We welcomed two new members to the Board. Ms. Emmy Vareberg and Mr. Ezra Ballinger were each appointed by the Governor of North Dakota to a five- year term.

The Board's Policy Manual and Human Resource manual were updated to provide clarity to the staff with respect to licensure and employee polices and benefits.

Legislatively, the Board proposed changes to their Administrative Code (NDAC Title 28). The North Dakota Administrative Rules Committee approved the proposed changes, which took effect October 1, 2021. The Board is assembling further change proposals for the upcoming legislative session, which begins in January of 2023

The Minnesota Board is in the rule writing process and finishing a deep dive of their statutes and rules. The statutory change would reduce the years of experience required to serve on the Board thereby increasing the pool of candidates qualified to serve on the Board. Other changes are also being made.

Since January of 2022, the Board has taken 15 enforcement actions. Those Orders are available on our web page.

Our 21-member Board has three new Board members and at this meeting we have members attending for the first time. The Board appreciates the funding opportunity NCEES has provided to facilitate greater participation.

### KANSAS STATE OF TECHNICAL PROFESSIONS' 2022 REPORT

The Kansas State Board of Technical Profession over the past year adopted and/or amended regulations including, K.S.A. 66-7-1 Applications.

That revised regulation lists the materials to be submitted with an application for reciprocity pursuant to 2021 HB 2066 to demonstrate status as a military servicemember or military spouse or to prove residence in Kansas or intent to establish residence in Kansas.

In addition to amending the reciprocity regulation the Board has been please to return to more normal operations following the COVID pandemic. Our staff works remotely with a rotating schedule of one employee in the office each day.

Board members began traveling again and attended both the Central Zone Meeting in Oklahoma City and the Annual meeting in Carlsbad. As MBE I participated in the MBE committee meetings.

We are looking forward to working with NCEES in the coming year.
