Funding	NCEES will provide the following funding, as applicable, for one individual from each board
summary	to attend the Law Enforcement Program: complimentary Law Enforcement Program registration, lodging expenses for up to three nights (August 20–22), and travel costs, per the travel policy. NCEES will also pay a one-time stipend to cover incidental expenses accordingly:

	• \$390 for those who fly
	No expense reports are necessary to receive this stipend. The check will be made payable to the individual (unless specified during registration) and will be received at registration. This is intended to cover expenses such as parking at your home airport, ground transportation, baggage fees, breakfast and dinner on Thursday, dinner on Friday, and incidental hotel charges, such as tips.
Registration and upgrade option	The Law Enforcement Program registration fee will be waived for funded individuals.
	Included meals are Thursday's lunch and Friday's breakfast and lunch.
	When registering online, these funded individuals will have the option to upgrade to a full annual meeting delegate registration for \$350. Additional hotel nights will be the individual's responsibility.
Hotel room	\$169/night for standard rooms, single or double occupancy
block rate	The rate does not include taxes (currently 16.75%) and fees (currently \$3 per night).
	NCEES will make the hotel reservations for all funded attendees based on information provided during registration and be direct-billed for room and taxes for up to three nights (August 20–22).

## Travel

**Fly:** NCEES will fund round-trip economy-class airfare to New Orleans. Funded individuals must follow instructions that will be provided in the meeting invitation. NCEES will be direct-billed for the cost of the airfare, per the travel policy.

**Drive:** Travelers who drive to the meeting will be reimbursed for mileage up to 1,000 miles at the IRS-recommended rate. The starting address will be provided during registration. The calculated amount will be added to the stipend check described above.

**Parking:** The cost for parking for funded nights will be covered by NCEES for funded attendees who are approved to drive to the meeting. More information about this will be provided in the invitation.
