

## 2025 NCEES Annual Meeting—Summary for funded Law Enforcement Program attendees

<b>Meeting dates and location</b>	<p>August 19–22, 2025</p> <p>Sheraton New Orleans Hotel 500 Canal Street New Orleans, LA 70130</p>
<b>Program summary</b>	<p>The Law Enforcement Program includes a forum on Thursday afternoon and a workshop on Friday.</p> <p>The content of the forum and workshop are still in development. Past forums have included presentations from licensing boards and roundtable discussions of law enforcement topics provided during registration. Last year's workshop was a full-day program given by the Public Agency Training Council (PATC).</p> <p>A draft schedule follows this summary. <b>Attendance requirements</b>	<p>Funded Law Enforcement Program attendees must attend the forum on Thursday afternoon and workshop on Friday.</p>
<b>Funding summary</b>	<p>NCEES will provide the following funding, as applicable, for one individual from each board to attend the Law Enforcement Program: complimentary Law Enforcement Program registration, lodging expenses for up to three nights (August 20–22), and travel costs, per the travel policy. NCEES will also pay a one-time stipend to cover incidental expenses accordingly:</p> <ul style="list-style-type: none"> <li>▪ \$200 plus and the approved mileage calculation for those approved to drive</li> <li>▪ \$390 for those who fly</li> </ul> <p>No expense reports are necessary to receive this stipend. The check will be made payable to the individual (unless specified during registration) and will be received at registration. This is intended to cover expenses such as parking at your home airport, ground transportation, baggage fees, breakfast and dinner on Thursday, dinner on Friday, and incidental hotel charges, such as tips.</p>
<b>Registration and upgrade option</b>	<p>The Law Enforcement Program registration fee will be waived for funded individuals.</p> <p>Included meals are Thursday's lunch and Friday's breakfast and lunch.</p> <p>When registering online, these funded individuals will have the option to upgrade to a full annual meeting delegate registration for \$350. Additional hotel nights will be the individual's responsibility.</p>
<b>Hotel room block rate</b>	<p>\$169/night for standard rooms, single or double occupancy</p> <p>The rate does not include taxes (currently 16.75%) and fees (currently \$3 per night).</p> <p>NCEES will make the hotel reservations for all funded attendees based on information provided during registration and be direct-billed for room and taxes for up to three nights (August 20–22).</p>

<b>Travel</b>	<p><b>Fly:</b> NCEES will fund round-trip economy-class airfare to New Orleans. Funded individuals must follow instructions that will be provided in the meeting invitation. NCEES will be direct-billed for the cost of the airfare, per the travel policy.</p> <p>A list of suggested ground transportation options will be available online at <a href="https://nces.org/annual_meeting">nces.org/annual_meeting</a> when registration opens.</p> <p><b>Drive:</b> Travelers who drive to the meeting will be reimbursed for mileage up to 1,000 miles at the IRS-recommended rate. The starting address will be provided during registration. The calculated amount will be added to the stipend check described above.</p> <p><b>Parking:</b> The cost for parking for funded nights will be covered by NCEES for funded attendees who are approved to drive to the meeting. More information about this will be provided in the invitation.</p>
