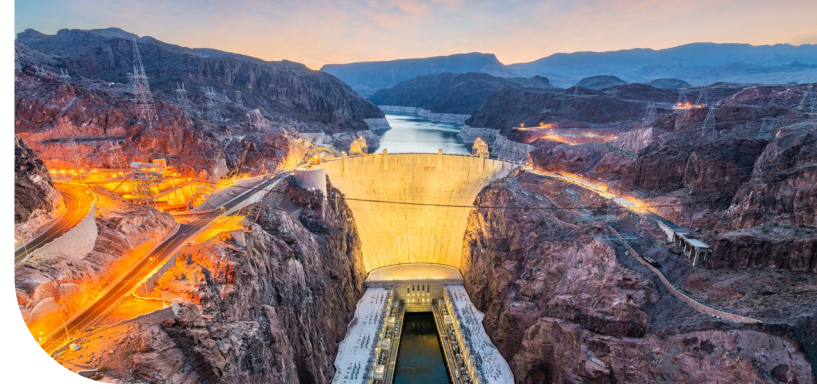

Join this forum to examine issues related to structural engineering licensure, including an update on the computer-based PE Structural exam.

The group will also discuss topics such as

- * Using artificial intelligence in structural engineering practice
- * Architects practicing structural engineering, particularly in jurisdictions that require S.E.s to design significant structures
- * The importance of developing consistent S.E. licensure across jurisdictions

TUESDAY, AUGUST 18

7:25–11:35 a.m.
**Behind-the-Scenes Technical Tour at
Hoover Dam (1 PDH)**

Experience Hoover Dam from an insider's perspective on this private, engineer-led technical tour. The route includes original rock tunnels, penstock and transformer viewing areas, and the powerhouse floor. This is not a public tour; it offers in-depth discussion of design, construction, and hydroelectric operations not typically seen by visitors.

This is only open to delegates and requires a \$50 fee. Participation is limited to 50 people. The guided tour lasts approximately one hour; the remaining time may be spent exploring the visitor center and observation deck. Closed-toe shoes are required to participate. Additional information is required for non-U.S. citizens (see registration system for more details).

Advocating for the Regulatory Boards

Josh Twitty, NCEES advocacy and external engagement strategist, will provide an update on recent legislative session trends and noteworthy licensing reform efforts, including relevant legislation impacting licensing departments, proposals to ease workforce challenges, and the best way to advocate for your board in a deregulation-inclined environment.

8:00–9:30 a.m.

Designing the Future: AI and the Licensed Professional (1.5 PDHs)

Artificial intelligence is rapidly reshaping engineering and surveying services. This session provides practical guidance on how licensed professionals can use AI in daily workflows while protecting their license, managing liability, and maintaining the standard of care. Attendees will explore real-world applications, ethical considerations, and the likely 2–3-year evolution of AI in the architecture, engineering, and construction industry, equipping professional engineers and surveyors to lead confidently in an AI-enabled future.

8:00–9:30 a.m.

Wild West on the Strip: Design and Construction of the Stratosphere Tower (1.5 PDHs)

In boom-time Las Vegas, the Stratosphere Tower was conceived and built under extraordinary constraints—ambitious vision, evolving codes, intense public scrutiny, and the unpredictable realities of Strip construction. The original structural engineer, Brent Wright, P.E., S.E., will share behind-the-scenes challenges, pivotal design decisions, jobsite surprises, and hard-earned lessons about risk, coordination, and engineering judgment that remain highly relevant to today's practitioners and regulators.

10:00–11:30 a.m.

Modernizing Survey Control: Preparing for the Modernization of the National Spatial Reference System (1.5 PDHs)

The National Geodetic Survey is ushering in a new era of positioning with the release of the modernized National Spatial Reference System, replacing legacy frameworks built on the North American Datum of 1983 and the North American Vertical Datum of 1988. This workshop will explain the major changes—including the transition to new geometric reference frames, the replacement of physical leveling-based heights with gravimetric geoid-based heights, and an increased reliance on global navigation satellite systems technology for precise positioning—as well as the impact on board rules and state laws.

10:00–11:30 a.m.

Speech or Conduct? The First Amendment and Professional Licensure (1.5 PDHs)

Numerous cases are challenging professional licensure laws on First Amendment grounds, focusing on the legal distinctions between regulating professional conduct and restricting protected speech. This presentation analyzes cases involving both the California and North Carolina boards as well as other occupational licensing boards and explores the rationale behind these challenges, how federal courts have approached the issue, and the implications of key U.S. Supreme Court decisions.

10:00–11:30 a.m.

Understanding Exam Development (1.5 PDHs)

NCEES Chief Officer of Examinations Lehmon Dekle, P.E., will explain the life cycle of an NCEES exam—from identifying the need for a new exam to developing, administering, and scoring the exam. This workshop is recommended for anyone wanting a better understanding of the exam development process, including first-time attendees and those interested in serving on an exam development committee.

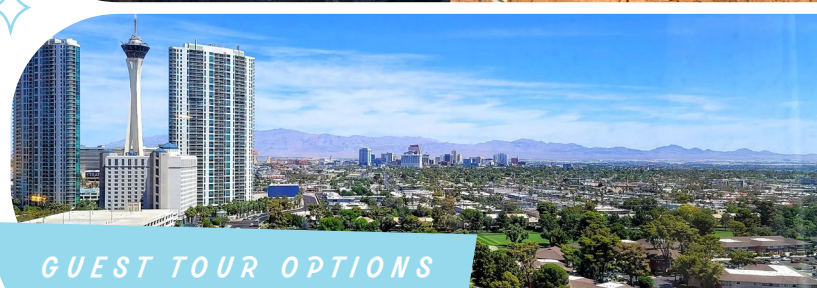

Printed copies will be available for delegates at the annual meeting.

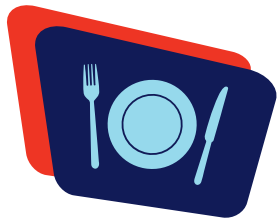

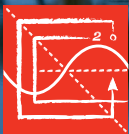
